

APPENDIX A: IDENTITY OF DEFENDANTS

JHS INC.

dba Jeeves Handyman Services

JHS INC. is a Maryland close corporation established on 3/28/01. Its address of record is 4401 East West Highway #308, Bethesda, MD 20814, and its resident agent is HIQ, 5th floor, 416 N. Charles St., Baltimore, MD 21201. **JHS INC.** was formed by **Sam R. Alameddine**, whose address was given as 4401 East West Highway #308, Bethesda, MD 20814.

A search conducted on the records of the Maryland Department of Assessments and Taxation (SDAT), Taxpayer Services Division, revealed that **JHS INC.** is not in good standing because it has failed to file its 2002 property return.

According to SDAT's records, the trade name Jeeves Handyman Services address listed as 4401 East West Highway #300, Bethesda, MD 20814 is associated with Securicare, LLC (of the same address). Securicare, LLC was established as a Maryland corporation established on 5/11/00, but its charter was forfeited on 11/15/01 for failure to file a 2001 property return. The resident agent for this lapsed corporation was **Sam Aleddine** at the address of record.

In addition, SDAT's records show that on 7/28/98, a corporation with the almost identical name Securicare LLC [no comma] was created. Its address of record was 4401 East West Highway #300, Bethesda, MD 20814, and its resident agent was **Sam Almeddine** of the same address. This corporation too has legally ceased to exist, as its articles of incorporation were voided on 1/14/99 for nonpayment.

The Internet domain name jeeveshandyman.com provides access to a website advertising the services of Jeeves Handyman Services at 4401 East West Highway #300, Bethesda, MD 20814, with a phone number of (301) 657-5885. The registration record for the domain name lists the registrant as NONE, 3400 Garrison St. NW, Washington, DC 20008.

The website also lists two contractor license numbers, MHIC 120499 (Md.) and 2705062980A (Va.). According to the Maryland Department of Labor, Licensing & Regulation, license 120499 (a business license for Jeeves Handyman Services) has lapsed. However, the Department's records show that an individual license (#77297-01) in the name of **Sam Alameddine**, with the address **JHS INC**, 3400 Garrison Street NW, Washington, DC 20008.

The records of the Virginia Department of Professional and Occupational Regulation (DPOR) Board for Contractors list license 2705062980 in the name JHS Remodeling, 3400 Garrison Street NW, Washington, DC 20008. DPOR's records also list license 2705060892 in the name Securicare LLC [no comma], trading as Jeeves Handyman Services (Arlington Co) with a mailing address of PO Box 730, Washington Grove, MD 20880.

The records of the Virginia State Corporation Commission indicate that JHS Remodeling, Inc. is a registered fictitious name for Maryland corporation **JHS INC.** mentioned above.

As noted above,

Sam R. Alameddine is the president of defendant corporation JHS INC.

Sam Aleddine was the resident agent for defunct corporation Securicare, LLC

Sam Almeddine was the resident agent for defunct corporation Securicare LLC [no comma]

Sam Alameddine holds a Maryland contractor license (MHIC 77297-01) associated with a business named **JHS INC** at 3400 Garrison Street NW, Washington, DC 20008

The records of the D.C. Office of Tax and Revenue list a **Sam R. Dean** as the owner (receiving the owner-occupant homestead deduction) of 3400 Garrison Street NW, Washington, DC 20008 (a/k/a square 2032, lot 0061).

Telephone records show that numbers (202) 362-1010 and (202) 686-5567 are both registered to **Sam Alameddine** at 3400 Garrison Street NW, Washington, DC 20008.
