Baggage is examined by Border Force and there are heavy penalties for making false declarations including possible forfeiture of goods.

How we use your information

Information given to the Border Force will be treated in confidence but may be used in support of any of its functions including, but not limited to, securing the UK border by enforcing customs and immigration controls. Where the law permits we may request information from third parties or give information to them. This might be to check its accuracy, protect public health, prevent or detect crime or protect public funds. The third parties may include police, other government departments or agencies, local authorities or foreign governments.

Goods contained in the baggage you listed overleaf

Prohibited and restricted goods include:

- Controlled drugs, such as heroin, cocaine, cannabis, amphetamines and lysergide (LSD).
- Firearms (including gas pistols, gas canisters, self defence sprays whether for self defence or not, electric shock batons, stun guns and similar weapons), ammunition and explosives (including fireworks).
- Obscene books, magazines, films, video tapes, DVDs, computer disks and indecent material featuring children.
- Horror comics.
- Flick knives, gravity knives, and certain other offensive weapons (including butterfly knives, disguised knives and some martial art equipment).
- Counterfeit and pirated goods and counterfeit currency.
- Radio transmitters (walkie-talkies, Citizen Band radios etc.) not approved for use in the UK.
- Animal products, including meat and fish, bivalves, honey, eggs, meat products, milk and dairy products.
- Some plants and plant produce (including trees, shrubs, bulbs, seeds, potatoes and certain fruit and vegetables).
- Most animals and birds, whether alive or dead (for example stuffed); endangered/protected species and certain articles derived from endangered/protected species.
- Cat and dog fur/harp and hooded seal pup skins and articles made from them.
- Rough diamonds without a valid Kimberly Process Certificate.
