- *Entries will not be accepted without an APDT Rally registration number.* To obtain a registration number, please complete the included Dog Registration Application and mail directly to the APDT Rally office.
- **Important: Please be sure to enter all digits of your Rally Registration Number correctly!** We are charged a fee for incorrect numbers and that fee will be passed on to you!
- **Important: Puppies may not be entered in any other class while being shown in the Puppy Level.**
- This is an indoor trial. Folding chairs are available, but please feel free to bring your own.
- Complimentary coffee and donuts will be available in the morning and snacks throughout the day.
- Fresh lunch buffet will be available--donations are appreciated.
- Refrigerator/freezer and microwave are available for your use.
- **Help support our trials by entering our fabulous raffles!**
- There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date. Refunds will be made for bitches in season if request is accompanied by a note from the exhibitor's veterinarian **before Dec. 18, 2009-**
- **Move-ups between levels will be allowed until 5pm, Nov. 30, 2009 via e-mail.** Move-ups from the A class to the B class are mandatory for teams who earn titles on date of trial.
- You may videotape your own run but may not videotape anyone else without his or her express permission.
- Dogs must be on leash at all times in the facility (when not in the ring) and on the grounds.
- PLEASE pick up after your dog! Supplies are provided outside the facility entrance in case you don't have your own.

We are the first two-story red brick building on right (PCOTC sign on side of building). Entrance is at the rear of the building, down the driveway between 230 Ferris and Condon Lumber.

From West: Route 287 to Exit 6. Right off ramp onto Route 22. First right onto Westview Ave. After left curve, turn right to stay on Westview, down hill. Left onto Ferris Avenue and proceed as above.

General Agreement

In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, PCRE, PCOTC, the Association of Pet Dog Trainers, Step in Time Training LLC, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official Rally-O Rules and Regulations of the Association of Pet Dog Trainers and the provisions for entry as set forth in the Rally Trial Schedule of which this entry form is a part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid. Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I (we) am (are) a family member of the dog's owner as stated and allowed in the APDT Rally rules, and that I (we) shall hold PCRE, PCOTC, Step in Time Training LLC, and APDT, including their officers, directors, employees and agents and their sponsors, harmless from any liability or claim made by dog's owner.

Further, I (we) hereby grant to the Association of Pet Dog Trainers, Port Chester Obedience Training Club, Port Chester Rally Enthusiasts, Step in Time Training LLC, or their representatives, agents, and assigns, all rights and permissions to use or appropriate my and the dog's name, biography, likeness, photograph, voice, performing persona, or other indicia or identity for broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known. I (we) hereby release APDT, PCOTC, PCRE, Step in Time Training LLC, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.

No telephone, e-mail, or fax entries will be accepted. **Checks must be payable to Step in Time Training, LLC.** Returned checks will invalidate entry and will be subject to a \$25 service charge.

IF you earn your title in any level at the PCRE trial, move ups from A to B are mandatory.

Please note the following for HOW TO ENTER: At the time you enter, if you have NOT earned a L1 title, you MUST enter L1A. If you have your title in L1 and you want to exhibit in L1, and you must enter L1B and you may enter L2A. If you have NOT earned a L2 title, you must enter L2A, and you may also enter L1B. If you have your L2 title and want to exhibit in L2, you must enter L2B and you may enter L3A, and you may also enter L1B. You need to have your ARCH title before accumulating QQs for the ARCHX, and you must have your ARCHX before accumulating QQs for your ARCHEX. You need to have your ARCHEX title before accumulating QQQs for the ARCHMX.

IF YOU RECEIVE YOUR TITLE IN ANY LEVEL BEFORE THE December 6th trial date and wish to move to another level, you must advise the Show Secretary via e-mail before 5pm, Monday, November 30, 2009. **No LEVEL move-ups after 5pm, November 30, 2009.** Move-ups from A to B are mandatory and will be made by the trial secretary day of trial.
