





**My name is Constable Richard H. Salter III. I have been serving as the Constable for the Office of the Pennsylvania State Constable in Eldred Township since 2008. My department's office is located at 516 Kunkletown Rd., Kunkletown, PA 18058. Since 2009, I have remained bonded, insured, and certified by the Pennsylvania Commission on Crime & Delinquency as per requirements under PA Act 49. I currently oversee one Deputy Constable, whom I had appointed in 2013 with the approval of the Monroe County Court of Common Pleas.**

**On December 14, 2017, I was issued an Order for Possession signed by Magisterial District Judge C. Daniel Higgins Jr from District Court 43-3-02. The docket number for the respective case is MJ-43302-LT-0000079-2017. As part of this assignment, and in accordance with the rules of civil procedure regarding this type of service, I drove to the rental property located at 5555 Glenbrook Rd, Stroudsburg, PA 18360 on 12/14/2017 in order to serve a copy of the Order for Possession, Return and Notice upon the defendant listed in this case, going by the name of Michael Rogers. For this service, I was in a full uniform, and was driving my fully marked Constable patrol vehicle. I was also wearing a body camera by which was activated from the moment I exited my vehicle, until I returned to the vehicle (video evidence has been, and continues to remain secured at this time.)**

**Upon my arrival to the rental property on 12/14/2017 at 1418hrs, I scanned the property for any activity, or dangers that would constitute an immediate officer safety or public safety concern. My first observation of the driveway and property was that the driveway was covered in a couple inches of snow, that did not appear to have been disturbed by any vehicle, person, or animal that would have left tracks in the snow. I did not observe any signs of dogs, no trespassing signs, or other signs that would indicate any immediate threat or likely threat to officer safety. In order to avoid getting stuck in the driveway with my vehicle, and still provide myself the ability to quickly escape if need be, I backed my vehicle into the driveway, and left it parked at the end of the driveway by the road.**

**After backing into the driveway, I exited my vehicle with paperwork in hand and proceeded to walk up the driveway cautiously approaching the residence for any threats or signs of possible danger. As I became closer to the residence I was able to see inside windows into the residence, but did not actually see anyone inside. The front entranceway to the residence was covered in snow that had not been disturbed. I continued to the back of the residence which appeared to be the regular entryway used by the occupants, and was next to where the occupant's vehicle, a grey minivan, was parked. Upon observation of this outer area of the residence, I noticed that the snow had been shoveled away from the doorway partly into the driveway. There was no vehicle, human, or animal tracks beyond the shoveled areas, indicating to me that there was likely to be an occupant/occupants inside the home. I proceeded to repeatedly knock on the door in an attempt to make contact with any occupant inside the dwelling. There were lights on inside the residence, however, no one came to the door; and I wasn't able to hear any movement, or sound coming from within the dwelling. After a few attempts at knocking at the door with no answer, I posted the residence with the Order for Possession, as well as a Notice To Tenant/Defendant, by affixing the paperwork to the door. I then closed the storm door, and returned to my vehicle. A copy of the Order for Possession is attached hereto as EXHIBIT "A".**

**Due to the computation of time regarding scheduling an eviction in accordance with the rules of civil procedure, I scheduled the Eviction for this case to take place on 12/26/17 at 1100hrs. I promptly contacted the Landlord (Paul) by phone to advise him of when the eviction would take place. He advised me that he would be at the property on the 26<sup>th</sup> to change the locks. He also advised me that he believed I may have a problem with the tenant as the defendant has made comments in the recent past suggesting that he would not leave the property easily. I thanked the landlord for the information, and advised him that I would be sure to bring some extra backup with me at the time of eviction to ensure it goes smoothly.**

**Shortly after contacting the landlord, I received a phone call from Nicole, a secretary from the District Court 43-3-02. Nicole informed me that the defendant in this case previously made concerning comments at the Court indicating that he may provide resistance with an ejection from the property. I thanked Nicole for the information and made sure to contact two other Constables ( Deputy Constable Virginia Salter and Deputy**



Constable Salvatore Furino ) to advise them of the situation and request their assistance on the day of the eviction. Both Deputies Furino and Salter acknowledged and said they would go along to provide assistance.

On 12/26/2017 at 1100Hrs, Deputy Constable Salvatore Furino, Deputy Constable Virginia Salter, and I arrived at 5555 Glenbrook Rd., Stroudsburg, PA 18360 along with the landlord in order to execute on the Order for Possession, and ultimately hand over control of the property back to the landlord. Upon our arrival, while approaching the residence, we made the observation that all of the windows to the residence had been covered by what appeared to be interlocking foam flooring tiles (brown in color) so as to block the ability to see inside the residence. There was a silver mini-van parked in the driveway. After approaching the doorway, we visualized a "NOTICE" that was posted on the storm door of the residence. The "notice" (attached to this report hereto as EXHIBIT "B") was directed to "those ordered to enter this house or garage by force", and threatened that if we were to "enter this inner door", that we "are in grave danger of causing potentially lethal bodily harm to yourself." The notice also directed us to a manila envelope that was attached to the inner door containing documents to review and "distribute as you see fit to those addressed in the cover letter". I retrieved the documents from the manila envelope. It was packet of five pages that were affixed together with one staple, and was addressed to "Constable Salter, Judge Higgins, PA Senator Scavello, and PA Governor Wolf".

After reading the cover page of this packet several things concerned me. I recognized that the letter contained signs similar to what I have seen in prior training concerning sovereign citizens and the type of rhetoric they often present to authorities. It contained suggestions that we are in violation of the Constitution, and that we have committed a multitude of federal crimes. The letter went on to contain statements such as, "... I don't want anyone harmed including myself, however I must preserve, protect, and defend the Constitution of the USA with my life if necessary as well as the dignity, honor, efforts, and history of my Parents in this house and garage as well as their ancestors..." and also, "... I hope those reading this have not been given orders to remove me by force from this residence I was raised at from birth till adulthood either dead or alive...". Said five-page document is attached to this report, as EXHIBIT "C".

It was evident to me that this landlord tenant case, and Order for Possession had just turned into a very volatile and dangerous situation. As such, I immediately made the decision to place ourselves in a safe position at the end of the driveway away from the residence, and afterwards, at 1106Hrs, I contacted the Monroe County Control Center to advise of the situation, and request a response from Stroud Area Regional Police before we tried attempting to make any further contact with anyone at the residence. Dispatchers from the Control Center acknowledged my request and stated they would send officers our way.

Shortly thereafter, A32- Police Officer Eilenberger from SARPD arrived onscene. I presented to him a copy of the Order of Possession we were there to enforce, as well as a copy of the letter that was on left for us on the door of the residence. After looking over the paperwork briefly, we (PO Eilenberger, Deputy Furino, Deputy Salter, and I) walked up to the residence to the door by which we located the letters from the defendant. At this time, another officer from SARPD arrived, A37- Police Officer Palmer, whom accompanied us at the residence.

PO Eilenberger attempted to make contact with the defendant, or any possible occupants in the residence by knocking on the door several times. Corporal Brown from SARPD then arrived on-scene, and was made aware of the situation. PO Eilenberger called the Monroe County Control Center to attempt to retrieve any contact information for the defendant so that we can attempt to call him via phone, while CPL Brown returned to his vehicle to advise his superiors of the situation. All officers from SARPD had agreed that this situation should be treated as a gunman barricaded in the residence, and any entry into the home at this point should be done by a SERT Team as none of us had the knowledge of whether or not any of the doors in the house had been booby-trapped, or if the defendant was inside the house awaiting with a gun. We were not aware of the layout of the residence, nor did we have any other information available to us, other than the fact that the defendant blocked all of the windows to stop anyone from seeing inside, and that he had left documents threatening the use of lethal force against anyone whom forces entry into the home in order to remove him from the property.

All officers decided to return to a safer location away from the residence until CPL Brown was able to make contact with his superiors about calling for a SERT team. After a few phone calls CPL Brown advised me that



his superiors would not call out the SERT team for this matter being that they considered it a Civil matter. CPL Brown suggested that we could "Sit on the house" and wait for the defendant to exit the residence by which we could then make contact and refuse to allow defendant to make entry back into the house. CPL Brown indicated that we could call them back at that time, and they would come out to provide further assistance with the defendant while the landlord changed the locks on the property.

At this time, I contacted the District Court 43-3-02 in an attempt to make contact with MDJ Higgins to advise him of the situation. I spoke with Nicole at the Court whom advised me that Judge Higgins was unavailable at that time, and that MDJ Muth was covering for him. After explaining the situation to the Courts secretary, I was placed on hold while she contacted MDJ Muth to advise of the situation. I had asked her to relay the information regarding this situation to the judge, and to determine if it would be possible to return the Order of Possession so that it could be re-issued to the Sheriffs office, as the Sheriff's office would likely have access to, or be able to get better access to, the necessary resources that are appropriate in this situation to make entry into this residence to enforce the Order for Possession that was issued by the Court. After a brief hold, Nicole returned to the phone line and advised me that MDJ Muth advised that if I felt the situation was unsafe, and if I was uncomfortable in making forcible entry to enforce the Order of Possession, that I could return the Possession to the Court so it could be redirected to the Sheriff's Office.

At this time, I advised SARP units on-scene that we would be returning the Possession to the Court so that it could be re-issued to the Sheriff's Office at a later date. SARP units acknowledged this plan and then left the scene. I then informed the landlord the same, and advised him that he would have to go to the MDJ Higgins office to re-file for another Order for Possession, and that I would be requesting that the Sheriffs Office be issued the Order to assist him further. The landlord agreed, and left the scene. Once the landlord left the scene, Deputy Salvatore Furino, Deputy Virginia Salter and I all left the scene clear and available for our next assignments.

Copies of this report will be submitted to District Court 43-3-02, Monroe County Court Administration, the Office of the Monroe County District Attorney, Stroud Area Regional Police Department, and the Pennsylvania State Police- Stroudsburg barracks. In conjunction with the submission of this report to the above agencies, I will be submitting a written inquiry to the office of the Monroe County District Attorney as to whether any criminal charges under 18 Pa.C.S.A. § 2706. (Terroristic threats), 18 Pa.C.S.A. § 3106. (Obstruction of Justice), and/or 18 Pa.C.S.A. § 5101. (Obstructing administration of Law or other governmental function) should be considered to be filed against the defendant regarding this case; in addition, as to whether or not a 302-involuntary commitment should be considered to address any underlying psychological issues that may be of concern in light of the events that have transpired in this case.



After all, our Parents couldn't even comprehend that, when all he had to do was attend Catholic ceremonies when at home to keep them hoodwinked. It was sad that after Tante Liesel died and her personal possessions were distributed without my consent or allowed my first choices bequeathed, none of my siblings would let me visit them in their homes any more. I already knew my siblings and Parents already took things from Tante Liesel's house they were not bequeathed, so I didn't think showing me those items was that big a deal. I just asked Tante Liesel the last time I visited her if she had ever met my Dad's Dad and what he was like, and much to my surprise, her initial answer was that back in those days they didn't know as much about menopause as they do today, which was quite an unusual answer, which I had no comment about, and being more concerned about my Dad's Dad which she said that he seemed like a normal nice guy to her which was good enough for me. We talked about a whole lot of other interesting things before wrapping up my visit attending to some minor plumbing issues she was having and having to leave till next time because my vacation was shortened by 5 days already needing a new transmission in my car during the trip east not expected, and I wanted to visit many more people and places before driving back to CA. My parents however confirmed my suspicions about what seemed possible about my Dad's Mom passing after thinking about what Tante Liesel said, but better yet, is that my Dad never complained about his Dad ever again in front of me. I had already learned that my Dad's Dad was a genius in his own right having been the first in the USA to figure out how to make the German theories of X-ray photography a practical reality for medical diagnosis and building the first machine ever used in the USA to look at a broken bone without surgery, and also can be considered the Father of Active Electronics being the first person on Earth to discover how to make a diode which made a lot of money for his employer who sold the patent, because he hired my Grandfather to figure out how to build a light bulb that had the light spectral content of the Sun for indoor photography at his many NYC studios. Next morning (March 21) over breakfast was the next surprise when my Parents wanted me to go to Utica NY with them because they had to meet an Attorney there. Mom said Dad could drive there and I could drive back which was fine with me. Originally it was claimed that Dad was just going to the Attorney's office to pick up the keys to Liesel Zuerker's house, which turned out a bit different once we got there. Dad was in the Attorney's office for a very long time getting the keys, and when he comes back to the car, his eyes and expressions were like he was in love, and wants only my Mom to go back into the office with him. This trip was certainly evolving strangely, and after my Mom and Dad come back to car, the plan was to go have lunch for an hour because it was close to noon, and then we were going to meet the Attorney at Liesel Zuerker's house. We went to a restaurant for lunch and then went to Liesel Zuerker's house where I met Lawrence W. Golden, the Attorney that had the key. For some reason Mr. Golden ignored me and only wanted to talk with my Parents at great length in the dining room about things I had no comprehension of that seemed to have a lot of anxiety or asked to join in the conversation. So I went outside to see what it looked like outside the house in early spring, which seemed normal, spent a few more minutes inside the house and helped my Mom carry some indoor plants to the car, and I drove back to Stroudsburg and got to my Parents house before dark.

My Mom showed me the Last Will and Testament of Liesel Zuerker she had received in Utica that day, and I was quite surprised that I was bequeathed first choice as to any tools and machinery that Liesel Zuerker may have to be mine absolutely and forever, and stranger yet since Lawrence Golden had ignored me in Utica and didn't inform me of that himself while I was there. When I asked my Mom what Mr. Golden had talked about when she was in his office, all she said was "not much". I'd already seen some unusual things happen in life, but being the first time I was named in a Will, this was evolving much stranger than usual. I don't know why my Dad mentioned that he had been named and bequeathed in over a dozen Wills before, but must have been important for some reason.

I spent the next week with my Parents that was rather unremarkable, and figured there must be some legal reason to wait till I got back to California to officially inform me about my bequeathment, and things were going to begin making sense regarding the events till then.
